#### **4. Entry**

The maximum number of pilots in the competition is 80 Pilots.

Min round for competition to be valid is 1 round ,max. 8 rounds .

#### **5. Entry Fee**

The Entry fee will be:

50eur per male pilot

40eur per female pilot

**The Entry fee includes:**

ID card and safety/contact information.

Competitor and glider identification.

Transport to take-off for on official training round and on competition days.

Daily snack package, water on official training round and on competition days. T-shirt.

Free access to all championship events and parties.

Emergency rescue and first aid medical service.

**6. Payments**

Entry fees, Are to be paid to registration process at the site directly cash to cashier .

**7. Pre-Registration**

Pre-registration for all pilots, will be opened on the competition website from March 22 to June 25th, 2021.

**8. Registration**

On registration day, pilots must report to registration office to have their documents checked and to receive supplementary information.

**9. Insurance**

The organizers require documentary proof in English of valid insurance covering public liability risk. Documentary proof must be presented to the organizers at registration.

**10. Equipment**

All equipment must abide by Section 7C.

### **11. Contest number**

According to Section 7C.

The number is 15 x 10 cm and must be displayed on the leg.

### **12. Radio**

Every pilot can fly with radio VHF

Radios are not to be used for the purpose of providing advantageous competitive information, for coaching. Only safety, organization and teams' frequencies allocated by the organizers must be used.

### **13. Safety Committee**

It will include 3 pilots.

### **12. Competition Site**

SKI CENTER ZARE LAZAREVSKI MAVROVO MACEDONIA

### **13. Number of rounds**

Maximum number of rounds - 8. One of the worst results will be drop off if we made 5 and more rounds

**Prize funds and scoring categories :**

Male medals - 1 2 3 + 500,300,200eur

Female medals - 1 2 3

**14. Rest day**

No specific rest day is planned

**15. Wind speed**

According to

Section 7C.

The maximum permitted wind speed, as measured at the target during the final 30 seconds of a competitor's flight, will be 5 m/s .

**16. Guest pilots**

For flying order purpose, guest pilots will be organized by the Meet Director.

Scoring of guest pilots according to Common Section 7.

**17. Amateur video evidence**

Amateur video evidence may be accepted.

Organizer will provide video recording on the landing. In the case where amateur video evidence is available when an official complaint is made, the Competition Director and Chief Judge reserve the right to choose whether and when to view that video evidence. The decision will be made on a case to case basis.

Further information on the policy on video evidence will be provided at the first pilot briefing.

## **19. Complaints and Protests**

According to General Section, Common Section 7 and Section 7C. The protest fee is 50 €. It will be returned if the protest is upheld.

## **20. Emergency Procedures**

One or Two emergency doctors ( with translators) and an ambulance with appropriate equipment will be available during all operations. The doctors will be at the landing. (The organizer will provide interpreters who will stay with the medical personnel and assist pilots is needed.) There are two possibilities for hospital within 15 min drive from Mavrovo, Emergency unit 5 min drive at Mavrovo and Hospital at Gostivar .

Accommodation and transfer

The organizers can help competitors to transfer from Skopje airport to hotels in Mavrovo .
